were in contact with ELIJAH and discussed the use of ELIJAH's Cadillac by MALCOLM, and ELIJAH told them that no one was to use his car and that was to get the keys and keep them.

ELIJAH told MALCOLM that he had instructed to let MALCOLM use car, while in

Chicago.

2/28/63

about MALCOLM and stated she was happy he had gone to New York the previous night and hoped he stayed there.

3/2/63

in contact with ELIJAH, advised that MALCOLM had called a meeting (of the family) and she did not think it was right, and she did not think MALCOLM could do what he wants to with the messenger's children. ELIJAH instructed to tell MALCOLM that they have a father to follow and guide them and do not need him (MALCOLM) as long as "Dad" is alive. ELIJAH continued that this is a family affair and we would be fools to spread it outside the family circle. (U)

<u>3/3/63</u>

was in contact with ELIJAH and said that MALCOLM was not teaching as well as before and ELIJAH asked if MALCOLM was going back to New York.

answered that he did not think so and that MALCOLM was going to stay and teach for a while, to which ELIJAH replied MALCOLM could just as well return to New York.

(ELIJAH) about the devils wanting to print in their paper that had retired and turned everything over to MALCOLM, and indicated he was quite upset by this "lie". Both and proceeded to "take MALCOLM apart." They also talked for some time on MALCOLM's statement that "anyone who moves into a white neighborhood was a fool," and that when someone pointed out to MALCOLM that FLIJAH had moved into an integrated ineighborhood, MALCOLM just repeated his statement. (U)

was in contact with ELIJAH and was tolling him how MALCOLM, whom he referred to as the "big chief", was teaching. ELIJAH then stated that MALCOLM thinks he can do better than all the others and has the right answers, but he is beginning to see that what he did in New York does not work in Chicago.

Then spoke with ELIJAH and both ridiculed MALCOLM and his belief that he can do so good. (W)

3/9/63

was in contact with and discussed with him the troubles he was having with NOI officers and told him that MALCOLM would try to help him. did not agree with this and stated that MALCOLM was playing "Mr. Inbetween" and added that MALCOLM was just trying to improve his own self. (L)

3/10/63

was in contact with ELIJAH in Phoenix and ELIJAH asked if MALCOLM was returning to New York tomorrow, to which replied that he did not know but did know that MALCOLM had scheduled



was in contact with and stated he heard MALCOLM was leaving, to which replied that he would be leaving this afternoon and that they could tell people that MALCOLM's wife fell and broke her leg, which she did, and that is the reason for MALCOLM's leaving. To this replied that he thinks he knows why, adding that when a man is supposed to be here on one thing and goes seeking, prodding and prying to find something else, he does not blame him (presumably ELIJAH MUHANMAD).


