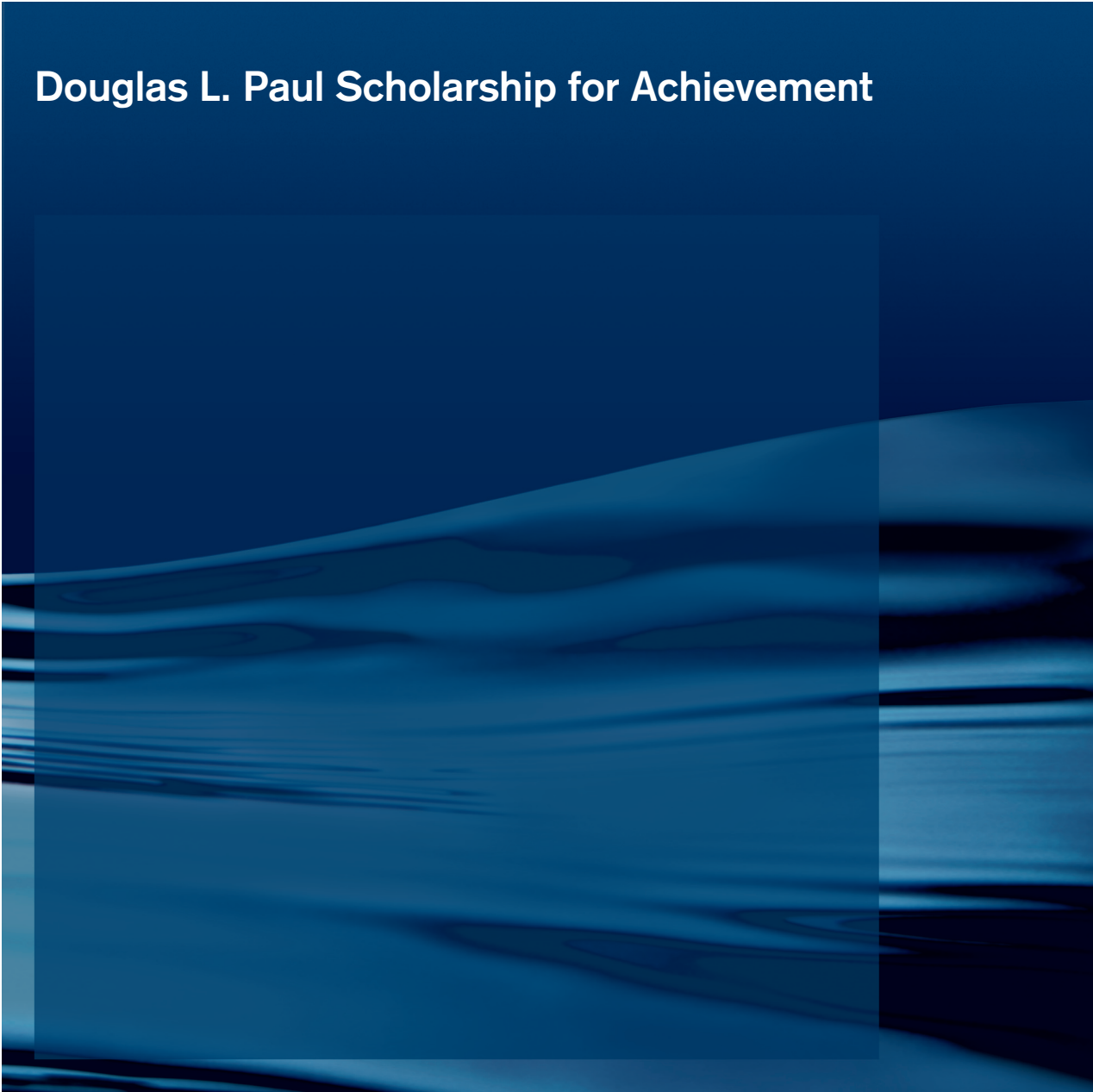


# Douglas L. Paul Scholarship for Achievement



## Douglas L. Paul Scholarship For Achievement

At Credit Suisse we strive to be at the forefront of the financial services arena. To accomplish this goal we are constantly identifying individuals who embody leadership, a desire to succeed, and innovation. We recognize the importance of diversity in attracting the best and the brightest to the Firm and, therefore, have created the Douglas L. Paul Scholarship for Achievement.

Credit Suisse will offer \$5,000 scholarships to a number of college sophomores of African, Latino, and Native American descent. Applicants must meet the eligibility criteria described below. Recipients of the scholarships will be selected based on their academic excellence, leadership abilities, and interest in the financial services industry.

In addition to monetary resources, students who receive the Douglas L. Paul Scholarship will have the opportunity to participate in our 10 week rotational program in New York. This unique 10-week placement provides students with an educational opportunity to learn about the various areas of an investment bank, with rotations through Credit Suisse's Equities, Fixed Income, and Investment Banking divisions. Scholars will not only be exposed to the world of financial services, but they will participate in a developed mentor program, participate in social activities where they will get to know Credit Suisse professionals as well as New York City, and attend weekly seminars with senior management.

Scholars will receive a stipend for the duration of the 10-week program.

### **Scholarship Program Overview:**

## Eligibility Requirements

Students must be enrolled full-time (at least twelve credits per semester) at an accredited four-year college and be a sophomore during the application process. Students majoring in any discipline(s) are encouraged to apply.

- Academic achievement
- Must be a sophomore at a four-year accredited college or university
- Demonstrate leadership and teamwork
- Active community involvement
- A cumulative minimum GPA of 3.4 on a 4.0 scale
- An interest in the financial services industry
- Applications must be **received** by November 29, 2007
