**Note:** An additional \$5.00 may be collected upon departure to pay for tips for the bus driver and ski tour staff.

\* **“Learn-to”** packages include a **lower-mountain** lift ticket, rental, and an introductory-level lesson. The lift ticket is good only at select lifts. If you have never skied/snowboarded, this is an appropriate option, but if you consider yourself an advanced beginner, we recommend that you **not** get a learn-to package.

\*\* The “Basic trip package” has 6 people per condo. If you have a **set group** of 4 or 5, and would like to have a **condo for only 4 or 5 people**, that option is available on a **limited basis**. 4 person occupancy is \$323.75/person (regardless of bed-type). 5 person occupancy is \$274 (regardless of bed-type). If you would like this option, contact Weilyn Pa ASAP.

**Sign-up & Payment instructions:** Please return this form and deposit to Weilyn Pa's (2L) folder on the third floor of the law school by due date. Upon paying your deposit, **sign-up for a specific bed & condo** on the sign-up sheet in Weilyn's folder. Please keep rooms single-sex unless everyone in the room agrees otherwise. If there is no space left for the bed of your choice, you must select a different bedding arrangement. Please return balance to same folder by due date. Pay by check payable to “Sno-Search” or cash.
