DESCRIPTION: Correspondence, manuscripts, notes, questionnaires and printed materials relating to a study of lynching conducted by the clergyman and economist, John Franklin Crowell (1857-1931; Ph.D. Columbia, 1897). Included are letters from governors, elected and appointed officials, and others replying to inquiries from Crowell. There are more than 100 items of manuscripts and manuscript notes by Crowell, 11 completed questionnaires returned to him, approximately 150 newspaper clippings and 12 printed items on the topic of lynching.
