DESCRIPTION:

The correspondence, notes, articles, reports, and speeches of Virginia C. Gildersleeve (1877-), Dean of Barnard College, 1917-1947. Included are materials relating to the United Nations Conference in San Francisco in 1945, the Dumbarton Oaks Conference, the International Federation of University Women; the American Association of University Women, The American Council on Education, and the Near East College Association. The most note-worthy item in the collection is a letter from President Franklin D. Roosevelt, appointing Dean Gildersleeve to serve as a member of the U. S. Delegation to the Charter Conference of the United Nations. The collection also contains some material relating to Barnard College affairs.
