DESCRIPTION:

Vincent, Mayor of Beaune--invitation to farewell dinner (See my "Lanes of Memory"); letter of invitation to French Homes Committee dinner from Sub-Prefect Grimanelli; Col. Reeves' memorandum in re Memorial, and his letter to H. B. Monges; letters of G.S.H. to Col. Reeves in re gifts to Art Institutions at Beaune; to Col. Erton in re Hospital and Convalescent Camps; to Lt. Callarius in re Hospital Section Expenses; to Gen. Rees in re Art Supplies; to Aymar Embury, Chief of Hospital Section (with Embury's reply); to Lt. Callarius, appointing him Embury's successor after A.E. returned to America; other items including G.S.H. honorable discharge from U.S. Army, July 15, 1919; membership lists of Army Educational Corps, etc.
- (3) Folder. Containing G.S.H. draft of General Orders to be issued from G.H.Q. (See note in back--Capt. Embury's comment and Gen. Rees' reply); letter of G.S.H. to Gen. Rees in re Paris Ateliers; report of Atelier progress; various letters to and from Embury and Callarius; letters to and from George Flossman (Etcher), Eugène A. M. Brown, Burton S. Stevenson, Col. C. W. Erton, and John Erskine; numerous documents, application for enrollment in Department of Fine and Applied Arts; letters and reports of Cyrus W. Thomas in re A.E.F. Soldiers in Paris Atelier--Académie Julian, Atelier Laloux and Atelier Harquette; various other papers.
