His Statements Scored As Unfair On Leadership

In a move to expose the "guilt by association" technique that has been used in recent months in New York County, Democratic County Leader Carmine G. De-Sapio has released to The New York County Democrat several documents that resulted from the hearing of the Kefauver Committee in New York last March.

The first document is a letter sent to Whitney North Seymour, president of the Association of the Bar of the City of New York, in which Mr. DeSapio urged establishment of a committee of New York's "ablest lawyers" to investigate the selection of judges in New York County.

Asserting that, because of the Kefauver hearing, "the man on the street now believes that it has been established that Costello controls the local Democratic Party, and what is more serious and what directly concerns the Bar Association, that Costello is the judge-maker in this County." DeSapio Issues Halley Tactics

Assaults on the unfair tactics of Rudolph Halley in his campaign against Joseph T. Sharkey, Democratic candidate for President of the City Council, came with increasing and telling regularity during the final days of the cam-

Among them was a broadcast by Emil K. Ellis, lawyer, who denounced the efforts to link Mr. Sharkey with corrupt elements through "guilt by association." Mr. Ellis pointed out that the same technique, as applied to Mr. Halley, called for some explanation as to why his law firm had represented and defended the late George Richards, radio station owner who has been noted as a bigot and anti-Semite.

"Now Mr. Halley," he said, "I do not claim you are anti-Semitic or intolerant, or that you share the views of that wretched hatepeddler. Of course, a lawyer may represent all kinds of clients without stigma, but it is also true that a lawyer has the right to refuse to accept retainers from people whose character he has no sympathy with."



The Democrats of New York County, together with right-thinking men and women of the entire city, are behind the candidacy of Joseph T. Sharkey, Acting President of the City Council, who is the regular Democratic candidate for the post. With this support, his election Tuesday, November 6, is assured.

Mr. Sharkey's record has been widely hailed as one of the finest of any legislator in office today.

He has acquired unique experience in the affairs of government as a legislator, as Vice Chairman and Majority Leader of the City Council, participating in the fight for veterans housing and civil rights.

Championing the fight for prevailing rate of pay for skilled labor was a victory ten years ago. His OPA Price Control Laws plugging the federal gap saved housewives from gougers. The Sharkey Uniform Laws outlawing the Nazi Bund in this City were copied in sixty major cities. He fought for better relations between labor and management. He organized and won for the Brooklyn Navy Yard a battleship contract when unemployment was at its lowest ebb in 1936, by setting up a committee of which he was the Chairman, and convinced the Navy and Congress to award the contract to build the battleship North Carolina at the Yard which put to

The answering letter of April 5 from Mr. Seymour was also released. Mr. Seymour explained that the Executive Committee of the Bar Association had turned down Mr. DeSapio's suggestion in as much as Governor Dewey had appointed a commission headed by John M. Harlan to "investigate generally the relationship between organized crime and any unit of government anywhere in the state," making the DeSapio suggestion unnecessary.

The third document is Mr. De-Sapio's statement of March 28, submitted voluntarily to the Kefauver Committee, which he call-ed "a record of my stewardship." In it he unequivocally denied allegations about the influence of Frank Costello in the organization of the Democratic Party in New York County. He said:

"Costello is not a power in Tammany Hall. He is not a power behind Tammany Hall. He does not dictate nominations. He does not select Judges. He does not control nor has he any influence over my policies or those of the Democratic Organization in this County in any way, shape or form, directly or indirectly. Since my election as Leader, Costello has never suggested, counselled or requested he added: any program or any choice of candidates."

Mr Halley, questioned about these charges by a group of New York City newspapermen immediately after Mr. Ellis's broadcast, admitted that his law firm had represented Richards before the Federal Communications Commission. He explained that he had obtained the approval of former Supreme Court Justice Meier Steinbrink, national chairman of the Anti-Defamation League of B'nai B'rith, something denied subsequently by Justice Steinbrink. The "morals" of Mr. Halley were
