Based on this scenario, we can say that (once we confirm that OK-1 is on site at the Superdome – they are due to arrive at 1 am)...that we have a DMAT team setup onsite at the Superdome. The team at the Superdome has tremendous past experience responding to Hurricane Ivan in 2004 and Hurricane Andrew in 1992. They also deployed to Tropical Storm Allison in 2001, the World Trade Center in 2001 and the Oklahoma City Bombing in 1995.

The state told us we would run out of places, the army told us they had run out of places. The leadership from top down in our agency is unprepared and out of touch. When told that the superdome had been evacuated and would be locked, Scott Wells said we shouldn't lock it becuase people might still need it in an emergency. Myself and the general who had been there immediately spoke up and told scott that it was impossible to send anyone back in there...is that not out of touch. But while I am horrified at some of the cluelessness and self concern that persists, I try to focus on those that have put their lives on hold to help people that they have never met and never will. And while I sometimes think that I can't work in this arena, I can't get out of my head the visions of children and babies I saw sitting there, helpless, looking at me and hoping I could make a difference and so I will and you must to. It is not what we do that is as important as who we are and that's what those little kids faces were counting on.
